



International Scholarships assist students effectively There are many international scholarships for Indian students

There are various international scholarships offered for students intending on studying abroad to assist their overseas education plans. The financial concerns to study abroad are made easier through such international scholarships.

The Fulbright – Nehru Master’s Fellowship

The United States India Education Foundation offers Fulbright scholarships to young and deserving Indian students. One of the most famous fellowships offered is the Fulbright – Nehru Master’s fellowship for leadership development for talented Indian students who wish to pursue higher education in any stream in the US. The eligibility criteria for this scholarship are given below.

- Students must have secured a **minimum of 55%** from a recognized Indian University.
- A four year bachelor’s degree is a mandatory requirement. If the student has a bachelor’s degree less than 3 years, then having at least a minimum of **three years of professional work experience** to the proposed field of study is a must.

- The student must not have a degree from another U.S university.

- The age limit is restricted between 25-30 years of age.

J.N. Ratan Tata Endowment Fund

The J.N Ratan Tata Endowment Fund was established in 1892 and it is extending its support to deserving Indian students to study abroad, by providing a **monthly stipend of 1000 US dollars, besides covering the full academic fees.** The organization is particular about encouraging students only with consistent academic records. The student must be less than 27 years of age at the time of enrolling for the scholarship.

The Paul Foundation Scholarship

The Paul Foundation scholarship is awarded to Indian students who wish to pursue their post graduate studies in India or overseas. It is an award of excellence for Indian students who have shown a **stupendous performance in their specialized department.** This international scholarship also gives them an opportunity to enhance their potential and develop their skills to become an aspiring leader in their field.

Bharath Petroleum Scholarship

This international scholarship is given by Bharath Petroleum Corporation Ltd. for Indian students who have secured at least 65% in arts and 70 % in engineering, science or commerce

departments in their undergraduate degree from a recognized university. It is applicable for Indian students who are under 25 years of age as on first of September of the year they apply.

Commonwealth Scholarship and Fellowship Plan

India, Canada, Australia, the UK and the other countries which constitute the Commonwealth government, are covered by the Commonwealth Scholarship and Fellowship Plan. However, this international scholarship is offered for students only within the commonwealth countries.

Rotary Scholarship

The prolific Indian students with first class honors in their related course are eligible to apply for this international scholarship program. Students/candidates with prior work experience are given preference. The student must be of 18-30 years of age during the time of enrollment. The Rotary scholarship covers a maximum of **10,000 US dollars**.

Some international scholarships cover only the study materials and course fee, whereas, a few other scholarships cover your accommodation, food and other basic living expenses in addition to your academic fee.
